IN FY 2017, OUR GRASSROOTS ORGANIZING WORK SUCCESSFULLY MOBILIZED THOUSANDS OF WILDERNESS ADVOCATES TO STAND UP FOR NEW MEXICO'S WILD PUBLIC LANDS. WE SUPPORTED ORGAN MOUNTAINS-DESERT PEAKS AND RIO GRANDE DEL NORTE NATIONAL MONUMENTS; CONTINUED OUR EFFORTS TO SECURE WILD AND SCENIC STATUS FOR THE GILA RIVER; EXPAND THE PECOS WILDERNESS; AND PROTECT WILDERNESS WITHIN THE RIO GRANDE DEL NORTE AND ORGAN MOUNTAINS DESERT PEAKS NATIONAL MONUMENTS.
