### Investing more in the Land of Enchantment Legacy Fund

Passed last year, the Land of Enchantment Legacy Fund is New Mexico's first-ever dedicated source of recurring funding for conservation, land and water stewardship, forest and watershed health, outdoor recreation and infrastructure, agriculture and working lands, historic preservation, and wildlife species protection. The Fund provides important matching funds to bring in federal dollars to the state. This year, the legislature provided an additional \$300 million appropriation. This permanent fund produces dividends that will pay 12% annually to a wide range of state agencies that manage conservation stewardship programs. The agencies will begin to receive these additional funds in 2025.

In a separate bill, the legislature approved the New Mexico Match Fund Act which provides \$75 million to help fill gaps that state, tribal, and local entities need to meet federal grant match requirements. The bill passed three committees in the House and Senate with unanimous bipartisan support from committee members.

### Big win for clean water

In this legislative session, \$7.6 million was appropriated to the New Mexico Environment Department to set up a surface water quality permitting program. Changes to federal protections under the Clean Water Act due to U.S. Supreme Court decisions in recent years has left New Mexico's waters arguably the most vulnerable in the country. The new permitting program will protect our rivers, streams, and wetlands for future generations.

### Questions remain on the Strategic Water Supply

One of the most challenging issues this legislative session was how to engage with the Strategic Water Supply initiative announced by Governor Lujan Grisham last December. Funding would purchase treated brackish and produced water to then be sold for industrial purposes. While New Mexico Wild appreciates our leaders thinking boldly about how to address our water crisis, we continue to have many questions about how the initiative would work, unintended consequences, and the utility of such a large investment when other solutions with broad consensus remain unfunded. We are grateful for more time to continue to work with the Governor's office, legislative leaders, and the New Mexico Environment Department to think through these questions.



## Other conservation bills from this year's legislative session

### Wildlife Corridor Funding

The fund aims to reduce animal-related vehicle collisions through highway infrastructure projects that include signage, fencing, and overpass/underpass projects. This also helps to promote habitat connectivity. Unfortunately, despite support from the governor, recommended funding was dramatically reduced. Our team and partners will continue to advocate for much-needed funding.

### Other Water Investments

The capital outlay bill included \$2 million for the River Stewardship Program with an additional \$1.25 million allocated to this program from the Land of Enchantment Legacy Fund. The bill also included \$5 million for acequia improvements statewide. The interest-generating Water Trust Fund received \$50 million for water-related projects vetted by the Water Trust Board. An important appropriation of \$7.5 million to the Strategic Water Reserve will provide funding for the state to purchase or lease water to benefit endangered species and for compact compliance.

### State Land and Water Conservation Fund

This Fund helps the state better access federal LWCF dollars. The LWCF has been an important conservation tool to safeguard natural areas, water resources, cultural heritage, and recreational opportunities. The updated fund prioritizes funding requests from Pueblos, Tribes, and rural communities.

### **Reform bills**

Both the Game Commission reform bill and the oil & gas reform bill stalled in this session, but advocacy work on these important initiatives continues.
